5. Eligibility and rules of origin

Participation is open on equal terms as described to commercial companies and non-governmental organizations, international and national, which are registered to perform disposal and/or demilitarization of ammunition activities and possess licence and all other relevant permissions to perform disposal and/or demilitarization of ammunition, issued by relevant national bodies, and as per Donor's specific decision.

The company/organization tendering shall have successfully completed as Prime or Sub-Contractor, at least 1 project of the same nature/amount/complexity comparable to the tendered works over the last 3 years, supported by the document(s)/confirmation(s) by relevant institution(s)/organization(s) (reference confirmation(s) – signed and stamped.

The company/organization is obliged to register and obtain DUNS number at <https://iupdate.dnb.com/iUpdate/mainlaunchpage.htm> before applying for this tender.

The company's principals/officials must not be on the Specially Designated Nationals List (SDN) - <http://www.treasury.gov/ofac/downloads/t11sdn.pdf> - of the U.S. Treasury Office of Foreign Assets Control (OFAC). The tenderer itself is responsible to check the SDN list.

Donor's specific conditions and requirements shall be taken into consideration at all tendering procedures.

6. Tender validity and tender guarantee

Tenders shall be valid for period of minimum 90 (ninety) days after the deadline for submission of Tender and must be accompanied by a Tender guarantee (values of the Tender guarantees are shown in the above table). The Tender guarantee shall be valid for a period up to and including minimum 90 (ninety) days after the deadline for submission of Tender. This guarantee will be released to unsuccessful Tenderer(s) once the tender procedure has been completed and to the successful Tenderer(s) upon signature of the contract by all parties.

7. Performance guarantees

The successful Tenderer will be asked to provide a performance guarantee of 10 % of the amount of the contract at the signing of the contract. Performance guarantee shall be valid for a minimum of 180 days after signing of the contract. If the selected Tenderer fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the Tenderer, which has submitted the second best admissible Tender.

8. Information meeting and/or site visit to inspect the project items

Site visit to inspect the project items with potential Tenderers is mandatory and will be organized, according to schedule/plan of inspection as set within tender documentation.

9. How to obtain the tender dossier

Interested eligible Tenderer(s) may purchase the Tender documents for the project at the ITF Headquarters in Slovenia (please contact Urša Marinšek Šrot at email address Ursa.Marinsek-Srot@itf.si), from **Monday, 24 September 2018** from 12:00 hours, and in following days. Tenders

must be submitted using standard Tender form included in the Tender dossier, of which format and instructions must be strictly observed.

11. Deadline for submission of tenders

The sealed Tenders shall be delivered by registered mail or in person, to **ITF Enhancing Human Security, Zabriv 12, 1292 Ig, Slovenia/EU** by **Monday, 22 October 2018 at 12:00 hrs** (local time). Any tender received after this deadline will not be considered.

12. Deadline for completion of works

All works on the projects under this Tender must be completed at the latest by **30 April 2019**.
