**2. Procedure:**

Call for proposals for commercial construction companies.

**3. Contracting Authority:**

ITF Enhancing Human Security (ITF)

**4. Description of the works:**

- Demolition and renovation of a warehouse in Osh, Kyrgyz Republic.

**5. Eligibility and rules of origin**

Participation is open on equal terms to commercial construction companies, international and national, which are registered to perform construction activities and possess license and all other relevant permissions to perform construction, issued by relevant national bodies of Kyrgyz Republic, and as per Donor's specific decision.

The company/organization submitting the offer shall have successfully completed as Prime or Sub-Contractor, at least 1 projects of the same nature/amount/complexity comparable to the procured works over the last 3 years, supported by the document(s)/confirmation(s) by relevant institution(s)/organization(s) (reference confirmation(s) – signed and stamped.

The company/organization is obliged to register and obtain DUNS number at <https://iupdate.dnb.com/iUpdate/confirmSource.htm> before applying for this tender.

The company's principals/officials must not be on the Specially Designated Nationals List (SDN) - <https://www.treasury.gov/resource-center/sanctions/sdn-list/pages/default.aspx> - of the U.S. Treasury Office of Foreign Assets Control (OFAC). The tenderer itself is responsible to check the SDN list.

Donor's specific conditions and requirements shall be taken into consideration at all tendering procedures.

#### **6. Offer validity**

Offers shall be valid for period of minimum 90 (ninety) days.

#### **7. Performance guarantees**

The successful company will be asked to provide a performance guarantee of 10 % of the amount of the contract at the signing of the contract. Performance guarantee shall be valid for a minimum of 180 days after signing of the contract. If the selected company fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the company, which has submitted the second best admissible offer.

#### **8. Information meeting and/or site visit to inspect the project objects**

Site visit to inspect the project objects with potential companies is possible and will be organized, according to schedule/plan ITF.
