## **INVITATION FOR SUBMISSION OF OFFERS FOR PROCUREMENT OF SERVICES FOR WEAPONS DISPOSAL IN BALYKCHY, KYRGYZ REPUBLIC**

### **2. Procedure:**

Open Call for Submission of Offers for Conventional Weapons Disposal

### **3. Contracting Authority:**

ITF Enhancing Human Security (ITF)

### **4. Description of the works:**

- Dismantling 60 pieces of 9K32M Strela-2M missiles in Balykchy, Kyrgyzstan
- Including permanent mutilation of grip stocks
- Including activation of thermal batteries
- Oversight of EOD procedures

### **5. Eligibility and rules of origin**

Participation is open on equal terms to commercial companies, international and national, which are certified for disposal of weapons and possess all other relevant permissions. Consortiums can apply if they can provide direct cooperation with producers of the equipment and guarantee implementation of contracts.

The company/organization submitting the offer shall have successfully completed as Prime or Sub-Contractor, at least 1 project of the same nature/amount/complexity comparable to the procured works over the last 5 years, supported by the document(s)/confirmation(s) by the relevant institution(s)/organization(s) (reference confirmation(s) – signed and stamped).

The company/organization is obliged to register and obtain UEI – Unique Entity ID (former DUNS number) at <https://www.gsa.gov/about-us/organization/federal-acquisition-service/office-of-systems-management/integrated-award-environment-iae/iae-systems->

The company's principals/officials must not be on the Specially Designated Nationals List (SDN) - <https://www.treasury.gov/resource-center/sanctions/sdn-list/pages/default.aspx> - of the U.S. Treasury Office of Foreign Assets Control (OFAC). The offeror itself is responsible to check the SDN list.

Donor's specific conditions and requirements shall be taken into consideration at all procedure.

## **6. Offer validity**

Offer shall be valid for period of minimum 90 (ninety) days after the deadline for submission of Offer and must be accompanied by an Offer Guarantee (issued by offerors bank) in the amount of 500.00 USD. The guarantee shall be valid for a period up to and including minimum 90 (ninety) days after the deadline for submission of Offer. This guarantee will be released to unsuccessful Offeror(s) once the procedure has been completed and to the successful Offeror upon signature of the contract by all parties.

## **7. Performance guarantees**

The successful contracted party will be asked to provide a performance guarantee of 10 % of the amount of the contract at the signing of the contract. Performance guarantee shall be valid for a minimum of 180 days after signing of the contract. If the selected company fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the company, which has submitted the second best admissible offer.

## **8. Information meeting and/or site visit to inspect the project objects**

Site visit to inspect the project objects with potential companies is possible and will be organized, as per ITF schedule/plan.
