



Based on the Assistance Measure to Strengthen the Capacities of the Balkan Medical Task Force (BMTF) financed by the European Peace Facility (Council of the EU adopted Decision (CFSP) 2022/906) through the ITF Enhancing Human Security (ITF), ITF would like to announce the following:

## **INVITATION FOR THE SUBMISSION OF OFFERS FOR THE PROVISION OF ROLE 2 FIELD HOSPITAL ITEMS**

### **2. Procedure:**

Open Full Procedure for International and/or Local Commercial Companies (Entities)

### **3. Contracting Authority:**

ITF Enhancing Human Security (ITF)

### **4. Description of the contract:**

The Beneficiary of the Assistance Measure is the Balkan Medical Task Force (BMTF) and its Participating Nations as the end users, namely Republic of Albania, Bosnia and Herzegovina, Montenegro, Republic of North Macedonia, and Republic of Serbia, where ITF Enhancing Human Security is acting as the Contracting Authority on behalf of the European Peace Facility (EPF) in this process.

Under this invitation for the provision of:

1. Modular Tents with connecting elements (44x),
2. Heating system for hospital tents (22x),
3. Air Condition and airflow tents system (22x),
4. Morgue container (2x),
5. Power Generators (3x),
6. Portable hand-washing station (14x), and
7. Field hospital beds with field bed mattresses (64x),

#### **5. Eligibility and rules of origin**

Participation is open on equal terms for all commercial companies, international and national. In order for Offerors to be considered eligible for the award of the Contract, it will be necessary for them to provide evidence that they meet or exceed certain minimum qualifying criteria.

The Offeror must provide an offer encompassing all items listed in point 4 above, including training, repair services, spare parts, and warranty services.

The Offeror shall have completed as Prime or Sub-Contractor, at least 2 sales/projects of the same nature/amount/complexity comparable to the offered goods and services over the last 2 years.

The Offeror shall organize and deliver the goods in line with INCOTERMS - DDP (Delivered Duty Paid) to the above stated delivery location and recipient.

The donor's specific conditions and requirements shall be taken into consideration at all stages of this procedure.

#### **6. Number of offers**

The Offeror may participate with only one offer for the same Contract. Submission or participation by an Offeror with more than one offer (either as a prime or a sub-contractor) for a Contract will result in the disqualification of Offeror as a prime contractor for that Contract in which the party is involved.

#### **7. Validity and guarantee**

The offered prices shall be valid for a period of a minimum of 90 (ninety) days after the deadline for submission of offers and must be accompanied by an Offer Guarantee (issued by the offeror's bank) in the amount of **21.750 EUR**. This guarantee will be released to unsuccessful Offeror(s) once the procedure has been completed and to the successful Offeror upon signature of the contract by all parties.

#### **9. Deadline for submission of offers**

The sealed Offers shall be delivered by registered mail or in person, to ITF Enhancing Human Security, Trg republike 3, 1000 Ljubljana, Slovenia / EU by **Friday, 19 April 2024 at 12:00 hours (local time)**. Any offer delivered after this deadline will not be considered nor accepted as a valid offer.

#### **10. Deadline for completion of goods and services contract**

All goods and services under this Invitation must be completed at the latest by **October 31, 2025**.

#### **11. Advance Payment Guarantees**

The successful contracted party will be asked to provide the advanced payment guarantee at the signing of the contract, The percentage of the advanced payment guarantee will be determined upon the advanced payment amount set in the contract. The advanced payment guarantee shall be valid from the date of the signing of the contract and until 30 days after the goods are delivered, installed and training conducted (if applicable). If the selected company fails to provide such a guarantee, the contract will be void and a new contract may be drawn up and sent to the company which has submitted the second-best admissible offer.
