5. Eligibility and rules of origin

Participation is open on equal terms for private business entities (companies).

Offeror shall not be considered eligible if:

1. Offeror is bankrupt, are having their affairs administered by the courts, have entered into an arrangement with creditors, have suspended business activities or are in any analogous situation arising from a similar procedure provided for in national legislation or regulations;
2. They are the subject of proceedings for a declaration of bankruptcy, for administration by the courts, for an arrangement with creditors or for any similar procedure provided for in national legislation or regulations;
3. They have been convicted of an offence concerning professional conduct by a judgment, which has the force of res judicata;
4. They have been convicted by final judgment of participating in a criminal organization, corruption, fraud or money laundering;
5. They are guilty of professional misconduct proven by any means, which the Contracting Authority can justify;
6. They have not fulfilled obligations relating to the payment of social security contributions in accordance with the legal provisions of the country where they are established; or have not fulfilled obligations relating to the payment of taxes in accordance with the legal provisions of the country where they are established;
7. They are guilty of serious misrepresentation in the supplying of the information required by the Contracting Authority as a condition of participation in the Invitation notice for submission of offers procedure.
8. They have been declared to be in serious breach of Contract for failure to comply with obligations in connection with another Contract with the same Contracting Authority or another Contract financed by community funds.

Offeror shall certify by an affidavit statement (Form of Affidavit Statement – Annex II) signed by their representative to the Contracting Authority that none of the situations detailed in Sub-Clauses 1 to 8 inclusive above applies to them.

If it is determined that the above statements are not accurate the Offeror agrees that the offer will be declared inadmissible by Contracting Authority, and as such rejected as administratively non-compliant. Such rejection applies to and can occur at any stage of the offer selection process, contract signing and/or during implementation of the project works.

6. General terms

- The offer shall be signed by a person or persons authorized to sign on behalf of the offeror using the Form provided in Annex II and Form of affidavit statement in Annex III.
- The currency of donation is the European Union Euro (EUR), therefore prices of the offer should be expressed in EUR. The prices should be stated without and with VAT.
- The material and equipment must be delivered to the Hospital in Bethlehem (Harmalah) and the transportation costs must be included in the final price presented in the offer. The delivery period must not exceed three months since signing of the agreement.
- The Contracting Authority (ITF) reserves the right to select the best Offeror for each/separate type and item of equipment, final selection will be made based on the funds available for the project. Offerors can present the offer containing all items, or only specific item from the list of the equipment indicated in Annex I.
- The warranty period for all items should be at least two years. Warranty periods must be clearly indicated in the offer. Samples of certain items might be requested.
- The offeror in the offered technical specification must indicate a guaranty deadline and warranty for the spare parts.
- The offeror will include in the offer copies of original documents indicating source of item, manufacturer's name and country of origin.
- In the offer shall be clearly indicated the cost for installation of equipment and training for handling the equipment.
- The Offer and all correspondence and documents related to this invitation for submission of offers exchanged by the Offeror and the Contracting Authority (ITF) shall be written in English, which is the language of procedure for this procedure. Also, all correspondence for payments including pro-forma invoice invoices, and final payment certificates shall be sent to the Contracting Authority (ITF) in English or local language with English translation.
- This Invitation notice for submission of offers is governed by the laws of the Republic of Slovenia.
- The offeror shall bear all costs associated with the preparation and submission of his Offer. In no case the Contracting Authority (ITF) will be responsible or liable for such costs, regardless of the process or results of the Invitation notice for submission of offers procedure.
- In case the Offeror acts as a party in a joint venture or a consortium of offerors, the contract shall be enclosed (i.e. a Partnership Agreement) stipulating how the public contract awarded within this procurement procedure will be executed, specifying, in particular, the leading partner authorized to assume from the Contracting Authority (ITF) obligations, instructions, and possibly payments on behalf of and for the account of all the partners, and the share and type of services

to be performed by each individual partner. The Agreement shall clearly stipulate that in relation to the Contracting Authority (ITF), all the partners are jointly and severally liable for the entire obligation and each part of it.

7. Evaluation of proposals

Acceptable offers will be evaluated by the Contracting Authority applying the criteria of technical suitability, lowest price, and delivery deadline. The Contracting Authority (ITF) using the lowest price, minimum requirement criterion, will evaluate acceptable offers. All offerors will be notified in written form selected by Contracting Authority (ITF).
