**5. Provisional period of Quality Assurance and Quality Control on demining program works in West Bank**

12 months - expected start and finish of QA/QC works is May 2017 till May 2018.

**6. Eligibility and rules of origin:**

Tender Participation is open on equal terms to QA/QC organizations, which possess the accreditation for quality assurance and quality control of demining works valid for the time of the planned start and finish of the works, issued by Israeli National Mine Action Authority.

The company/organization is obliged to obtain DUNS number at <https://iupdate.dnb.com/iUpdate/mainlaunchpage.htm> and register to SAM.gov system before applying for this tender.

The company's principals/officials must not be on the Specially Designated Nationals List (SDN) <https://www.treasury.gov/ofac/downloads/sdnlist.pdf> - of the U.S. Treasury Office of Foreign Assets Control (OFAC). The tenderer itself is responsible to check the SDN list.

#### **7. Number of tenders**

The Tenderer may participate with only one Tender for the same Contract. Submission or participation by Tenderer with more than one Tender (either as a prime and a sub-contractor) for a Contract will result in the disqualification of Tenderer as a prime contractor for that Contract in which the party is involved.

#### **8. Tender validity and tender guarantee**

Tenders shall be valid for period of minimum 60 (sixty) days after the deadline for submission of Tender and must be accompanied by a Tender guarantee (values of the Tender guarantees are shown in the above table). The Tender guarantee for the contract shall be valid for a period up to and including minimum 60 (sixty) days after the deadline for submission of Tender. This guarantee will be released to unsuccessful Tenderer(s) once the tender procedure has been completed and to the successful Tenderer(s) upon signature of the contract by all parties.

#### **9. How to obtain the tender dossier**

Tenders must be submitted on the standard tender form included in the tender dossier, whose format and instructions must be strictly observed.
